### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated February 05, 2024, placed the rating(s) of Dynamic Engineers (DE) under the 'issuer non-cooperating' category as DE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 21, 2024, December 31, 2024 and January 10, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

It is engaged in the business of fabrication for Railways with major focus on fabrication of steel structures, glued joints and supply of Steel Bridges, Girders and track fittings with approval of Ministry of Railway (RDSO). Further, the promoters has also incorporated DEIPL in 2007 which is engaged in the field of civil works for Railways like Railway Track, Bridges, Limited Height Subway, Railway Over Bridges etc.
