## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 09, 2024, placed the rating(s) of Marvest Aqua Protein Private Limited (MAPPL) under the 'issuer non-cooperating' category as MAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 24, 2024, December 04, 2024 and December 14, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings for MAPPL have been revised on account of non-availability of requisite information.

### About the company

Marvest Aqua Protein Private Limited (MAPPL) was incorporated on March 9, 2018 under companies' act 2013. It is based on Nagapattinam, which is a coastal area in Tamil Nadu. The company proposes to engage in manufacturing of fish meals, used as feeds in commercial fish farms mainly for Shrimps, and fish oil. The company intends to exports its products to countries such as China, Vietnam. Mr. K Muhammed Ashraf, Mr. Pathoor Hussain Mohamed Ismail and Mr. Sheik Dawoodh are the directors of the company. With the upgraded manufacturing unit the company will have a production capacity of 22 tonnes of fish meals per day.
