## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated February 01, 2024, placed the rating(s) of Sai Constructions\_Hyderabad (SC) under the 'issuer non-cooperating' category as SC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 17, 2024, December 27, 2024, January 06, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Hyderabad based, Sai Constructions (SC), was incorporated in the year 1992 as a partnership firm, with its registered office at Barkatpura, Hyderabad. The partners of the firm are Mr. B. Madhava reddy (Managing Partner), Mr. M. Janardhan reddy and Mr. C. Narsimha reddy who have experience for more than two decades in construction industry. The firm is primarily engaged in civil construction works relating to laying of roads, constructing of buildings, water pipe lines. The firm procures its work orders through online tenders majorly from Ministry of Defense. The firm has order book position of Rs.11.93 crore as on July 17, 2018 and the same is likely to be completed by April 2019.
