### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 10, 2024, placed the rating(s) of Raghuvanshi Cotton Ginning And Pressing Private Limited (RCGPPL) under the 'issuer non-cooperating' category as RCGPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RCGPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 25, 2024, December 05, 2024, December 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
