CARE Ratings Ltd. had, vide its press release dated January 04, 2024, placed the rating(s) of Ruchi Worldwide Limited (RWL) under the 'issuer non-cooperating' category as RWL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RWL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 19, 2024, November 29, 2024, December 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

RWL is based of Indore, Madhya Pradesh and is an international trading arm of the group and is involved in trading of various agri-commodities including edible oil, raw cotton, castor seeds and oil, coffee, grain and pulses. In pursuance of implementation of Resolution Plan approved by the NCLT Ruchi Soya Industries Limited has transferred its entire ownership in Ruchi Worldwide Limited (52.48%) to Sanatan Multi Skill Development and Education Private Limited on 27th March, 2020. The balance (47.52%) is held by Dinesh Khandelwal (Trustee of Disha Foundation Trust).
