Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 25, 2024, placed the rating(s) of North Bihar Construction Private Limited (NBCPL) under the 'issuer non-cooperating' category as NBCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NBCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 10, 2024, December 20, 2024, December 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

North Bihar Construction Private Ltd (NBCPL) was incorporated in October 1983 by the Singh family of Patna, Bihar. Since its inception, the company has been engaged in civil construction business in the segment like roads, bridges and railway projects. NBCPL is an ISO 9001:2008 certified company for implementing quality management system by Transpacific Certifications Ltd. Further, the company is also classified as class 'A' contractor by the State Government of Bihar. Mr. Awadh Kishore Singh (Managing Director) has more than three decades of experience in civil construction industry, looks after the day to day operations of the company. He is supported by other directors who are also having long experience in this industry.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of NBCPL into ISSUER NOT COOPERATING category vide press release dated May 24, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
