Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 15, 2024, placed the rating(s) of Unipearl Alloys (UA) under the 'issuer non-cooperating' category as UA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 31, 2024, January 10, 2025 and January 20, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Unipearl Alloys (UA) based in Mandi Gobindgarh, Punjab is a partnership firm established in April, 2005 by Mr. Kuldeep Singh Kalsi, Mr. Pargat Singh, Mr. Rajveer Singh, and Mr. Vikramjeet Singh. UA is primarily engaged in the manufacturing of mild steel ingots, square steel billets, forging ingots, etc. Mild steel ingots produced by UA find application in rolling mills to manufacture steel sheets, channels, bars and plates which are then used in construction and infrastructure industry. the manufacturing facility of the firm is located at Mandi Gobindgarh, Punjab.
