Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated January 29, 2024, placed the rating(s) of Shree H.D. Overseas (SHO) under the 'issuer non-cooperating' category as SHO had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHO continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 14, 2024, December 24, 2024, January 03, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm commenced operations in November, 2016. SHO is engaged in processing of paddy at its unit located at Karnal, Haryana

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SHO into Issuer Not Cooperating category vide press release dated August 16, 2024 on account of its inability to carry out a review in the absence of requisite information.
