### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 16, 2024, placed the rating(s) of Amsat Industries Private Limited (AIPL) under the 'issuer non-cooperating' category as AIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 01, 2025, January 11, 2025 and January 21, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Amsat Industries Private Limited (AIPL) was incorporated in 2009 by Mr. Kuldip Singh Dalal and Ms. Cornolia Dalal and started its commercial operations in 2012. The company is being managed by Mr. Kuldip Singh Dalal. The company is engaged in manufacturing of heat sink and metal cabin. A heat sink is a component used in electrical machine to lower the temperature of an electronic device by dissipating heat into the surrounding air. The manufacturing facility of AIPL is located at Jhajhar, Haryana.
