B continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 04, 2024, December 14, 2024, December 24, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Bellefonds was established as a partnership firm in January 2015 by Mr. Prahlad Singh Gujral and Mrs. Echha Gujral for setting up a manufacturing unit of Roofing sheets. The firm has set up the manufacturing unit with an aggregate cost of Rs.7.37 crore financed at a debt equity of 0.69x. The firm has started its commercial operations from April 2017. The manufacturing facility of the firm is located at Sonapur, Assam.
