### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 16, 2024, placed the rating(s) of S.S. Khardekar India Private Limited (SKIPL) under the 'issuer non-cooperating' category as SKIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 01, 2025, January 11, 2025, January 21, 2025 and February 26, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

**Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).**

The rating assigned to the bank facilities of SKIPL have been revised on account of non-availability of requisite information. Further, revision also considers delays in debt servicing recognized from publicly available information.
