### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 29, 2024, placed the rating(s) of Choudhary Brothers Agri Exports Private Limited (CBAEPL) under the 'issuer non-cooperating' category as CBAEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CBAEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 14, 2025, January 24, 2025 and February 03, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
