Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 06, 2024, placed the rating(s) of Kaila Devi Healthcare Services Private Limited (KDHSP) under the 'issuer non-cooperating' category as KDHSP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KDHSP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 22, 2024, January 01, 2025 and January 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of KDHSP have been revised on account of non-availability of requisite information.
