### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 01, 2024, placed the rating(s) of Kathpal Solvex Private Limited (KSPL) under the 'issuer non-cooperating' category as KSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 17, 2024, December 27, 2024, January 06, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Kathpal Solvex Private Limited (KSPL) was incorporated in 2001 as a private limited company and is currently being managed by Mr. Krishan Lal and Mr. Ravi Kumar. The company is engaged in processing of paddy to manufacture basmati and non-basmati rice at its manufacturing facility located in Fazilka, Punjab.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of KSPL into Issuer Not Cooperating category vide press release dated March 26, 2024 on account of its inability to carry out a review in the absence of requisite information.
