CARE Ratings Ltd. had, vide its press release dated January 31, 2024, placed the rating(s) of P Damodara Raju (PDR) under the 'issuer non-cooperating' category as PDR had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PDR continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 16, 2024, December 26, 2024 and January 05, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
