### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 30, 2024, placed the rating(s) of SMT Machines (INDIA) Limited (SML) under the 'issuer non-cooperating' category as SML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 15, 2024, December 25, 2024 and January 04, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### **About the company**

The entity, an ISO 9001:2008 certified company, was incorporated in June, 1992 as a private limited company by the name of Aman Multilateral Private Limited, however, in December, 1994, the constitution and name was changed to SMT Machines (India) Limited (SML). The company is currently being managed by Mr. Surinder Kumar Mittal and Mr. Raman Mittal. SML is engaged in manufacturing of capital goods like shearing machines, conveyors, straightening machines, mill stands, gear boxes, cooling bed, etc. which find their application in steel and iron rolling mills at its manufacturing plant located in Mandi Gobindgarh, Punjab.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SML under Issuer Not Cooperating category vide press release dated September 16, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
