Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 17, 2024, placed the rating(s) of Joy Mahaprovu Cold Storage Private Limited (JMCSPL) under the 'issuer non-cooperating' category as JMCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JMCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 02, 2024, December 12, 2024, December 22, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Joy Mahapravu Cold Storage Private Limited (JMCSPL) was incorporated on June 1996 for setting up a cold storage facility by Dhawa family of Paschim Medinipur, West Bengal. JMCSPL is engaged in the business of providing cold storage services for potatoes to local farmers and traders on rental basis with an aggregate storage capacity of around 8,000 metric ton per annum (MTPA). The cold storage is located at Paschim Medinipur district of West Bengal. Besides providing cold storage facility, the company also provides interest bearing advances to farmers and traders for potato farming and storing purposes against potato stored.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of JMCSPL into ISSUER NOT COOPERATING category vide press release dated October 09, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
