Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 22, 2024, placed the rating(s) of Sri Thirunavukkarasu Dhanalakshmi Educational And Charitable Trust (STDECT) under the 'issuer non-cooperating' category as STDECT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STDECT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 07, 2024, December 17, 2024 and December 27, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sri Thirunavukkarasu Dhanalakshmi Educational and Charitable Trust (STDECT) was registered as public charitable trust in the year 2000 to spread higher technical and engineering in the industrially backward taluks and districts of Tamil Nadu. Mr. R. Thirunavukkarasu is the founder and Managing trustee/ Chairman. The trust operates two educational institutions namely, Arasu Engineering College providing five U.G. programmes and three P.G. programmes and Arasu Polytechnic College providing five diploma programmes. Arasu Polytechnic College commenced from academic year 2015-16 onwards.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of STDECT into Issuer Not Cooperating category vide press release dated May 23, 2024 on account of its inability to carry out a review in the absence of requisite information.
