Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 06, 2024, placed the rating(s) of Calyx Spaces LLP (CSL) under the 'issuer non-cooperating' category as CSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CSL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 22, 2024, January 01, 2025 and January 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Established in the year 2017, CSL is the special purpose vehicle (SPV) of the Pune based real estate developer, Calyx group (CG). The group has completed 21 residential cum commercial projects of total area of 23.53 lsf in Pune since 2007. CSL was established with a view to execute the real estate project namely 'Atulya' in Jambhul Talegaon, Pune. 'Atulya' is being developed under revenue sharing agreement with 78% of revenue generated will be received by CSL. CARE does not have any update on the aforementioned.
