### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 02, 2024, placed the rating(s) of Shree Hari Spintex Limited (SHSL) under the 'issuer non-cooperating' category as SHSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHSL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 18, 2024, December 28, 2024 and January 07, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in 2007, Shree Hari Spintex Limited (SHSL) is promoted by Mr Rakesh Kumar and is engaged in the production of cotton yarn at its manufacturing facility located at Maur Mandi, Distt. Bathinda, Punjab. The operations commenced in FY08, with FY09 as the first full year of operations for the company. The products manufactured by the company find its application in the March 31, 2016, for the manufacturing of cotton yarn for counts ranging from 16s to 34s.
