Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 19, 2024, placed the rating(s) of Luxra Enterprises Private Limited (LEPL) under the 'issuer non-cooperating' category as LEPL had failed to provide information for monitoring of the rating to in its Rating Agreement. LEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 04, 2025, January 14, 2025 and January 24, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of LEPL have been revised on account of non-availability of requisite information.
