Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 14, 2024, placed the rating(s) of Anjaneya Breeding Farm and Hatcheries (ABFH) under the 'issuer non-cooperating' category as ABFH had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ABFH continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 30, 2024, January 09, 2025, January 19, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Belgaum, Karnataka based, Anjaneya Breeding Farm and Hatcheries (ABFH) was established by Mr. Sadashiv V. Deshinge as a proprietorship firm in the year 2004. The firm is a partially integrated unit engaged in poultry farming along with manufacturing of animal and poultry feed, sale of one day old chicks, broilers and rearing of parent birds.

Status of non-cooperation with previous CRA: Acuite has continued the ratings assigned to the bank facilities of ABFH to the 'issuer not-cooperating' category vide press release dated January 09, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
