Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated January 23, 2024, placed the rating(s) of Esteem Industries Inc. (EII) under the 'issuer non-cooperating' category as EII had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EII continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 08, 2024, December 18, 2024, December 28, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The entity was established as a partnership firm in 1984 under the name of "Vikrant Equipments". However, in January 2007, the firm changed its name to "Esteem Industries Inc." and is currently being managed by Mr. Mahendra Tandon, Mr Vipul Tandon and Mrs Roma Tandon, as its partners. EII is engaged in the manufacturing, trading and installation of medical, surgical and scientific laboratory instruments such as autoclaves, sterilisers, medical equipment, hospital furniture, consumable products, personal protection equipment, pathology products, etc, at its manufacturing facility located in Baddi, Himachal Pradesh.
