Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 01, 2024, placed the rating(s) of Patiala Distilleries And Manufacturerslimited (PDM) under the 'issuer non-cooperating' category as PDM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PDM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 17, 2024, December 27, 2024 and January 06, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company is currently being managed by the directors- Mr. Sudarshan Kumar Modi, Mr. Sanjeev Kumar Modi, Mr. Tarun Kumar Modi, Mr. Kewal Aggarwal and Mr. Virendra Swarup Agarwal. The company is engaged in the manufacturing of rectified spirit (RS) and extra neutral alcohol (ENA) and sells it in the form of Country Liquor (CL) and India Made Foreign Liquor (IMFL).
