Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 11, 2024, placed the rating(s) of Saibaba Agrotech Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 26, 2024, December 06, 2024, December 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Saibaba Agrotech Private Limited was incorporated in January 2008 with an objective to enter into the rice milling and processing business. The manufacturing unit of the company is located at Konari, Pisegaon, Dist; Durg, Chhattisgarh with an installed capacity of 43200 metric tons per annum. The company is procuring raw paddy from the local farmers and small paddy agents.
