### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 19, 2024, placed the rating(s) of Adig Jemt看 Private Limited (AJPL) under the 'issuer non-cooperating' category as AJPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AJPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 02, 2025, February 12, 2025 and February 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Bhilwara (Rajasthan) based Adig Jemt看 Private Limited (AJPL) was incorporated by Mr. Nand Kishore Jindal and Mr. Madhur Jindal in 2010. Subsequently, there was change in share holding pattern in 2014 with exit of Mr. Madhur Jindal and entry of two new directors namely, Mr. Akash Jindal and Mrs. Kavita Jindal. Initially, AJPL was engaged in the business of seizing of yarns (mainly starching process) and trading of grey and finished fabrics. However, from June 2017, it has started commercial production of grey fabrics. The plant of the company is located at Bhilwara.
