Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 18, 2024, placed the rating(s) of Gowtham Cements Private Limited (GCPL) under the 'issuer non-cooperating' category as GCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 10, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings for GCPL have been revised on account of non-availability of requisite information. The rating revision also considers delays in debt servicing as recognized from lender feedback.

Gowtham Cements Private Limited (GCPL) was incorporated in September'2009, by Mr. C.N. Murthy (Managing Director), Ms. Kavitha (Director) and other family member, for manufacturing of cement. The promoters of the company are qualified and have more than two decades of experience in civil construction and other business. The manufacturing unit of the company is IN 7.5 acres and is located at Pachanapalle Village, Chittoor Mandal, Chittoor, Andhra Pradesh. The Company sells its products 75% in Tamil Nadu and remaining 25% in Andhra Pradesh. The company purchases clinker, fly ash, gypsum and other raw materials required in manufacturing in cements from Andhra Pradesh (75%) and remaining from Tamil Nadu region.
