## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 24, 2024, placed the rating(s) of Shrikalyani Agritech Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 09, 2024, December 19, 2024, December 29, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Shrikalyani Agritech Pvt. Ltd. (SAPL) was incorporated in June 2009 as Shri Kalyani Coke & Iron Pvt. Ltd. (SCIPL) by Goyal family of Dhanbad, Jharkhand. SCIPL was de-functional and later on in May, 2013, it was renamed to Shrikalyani Agritech Pvt. Ltd. for the purpose setting up a paddy processing unit at Govindpur, Dhanbad, Jharkhand. The company commenced commercial production in July, 2014 with rice processing capacity of 32,620 metric tonne per annum (MTPA).
