Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 21, 2024, placed the rating(s) of J.B.R. Technologies Limited (JTL) under the 'issuer non-cooperating' category as JTL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JTL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 06, 2025, January 16, 2025 and January 26, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The entity was initially incorporated as a private limited company in 2005, however, in December 2017 it was reconstituted as public limited company and is currently being managed by Mr. Rajinder Singh and Mrs. Renu Chaudary and Mr. Dishant Chaudary.
