Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 14, 2024, placed the rating(s) of Enn Aar Poles (EAP) under the 'issuer non-cooperating' category as EAP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EAP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 30, 2024, January 09, 2025 and January 19, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
