Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 12, 2024, placed the rating(s) of Lodhi Rajpoot Ice And Cold Storage Private Limited (LRICS) under the 'issuer non-cooperating' category as LRICS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LRICS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 28, 2024, January 07, 2025 and January 17, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings for LRICS have been revised on account of non-availability of requisite information.

The company is currently managed by Mr. Mohan Datt & Mr. Ram Gopal. The company is engaged in renting of its cold storage facility for potatoes to the local farmers in Shikohabad, Uttar Pradesh with multi chambers
