### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 31, 2024, placed the rating(s) of Haraparbati Potato Cold Storage Private Limited (HPCSPL) under the 'issuer non-cooperating' category as HPCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HPCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 16, 2024, December 26, 2024, January 05, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Haraparbati Potato Cold Storage Private Limited (HPCSPL), incorporated in the year 2016, is a Hooghly (West Bengal) based company. It is engaged in the business of providing cold storage services to potato growing farmers and potato traders, having an installed storage capacity of 120,000 quintals in Vill- Pursurah, Hoogly district of West Bengal. The current directors have taken over the cold storage facility of "Hara Parbati Potato Cold Storage Private Limited" and started commercial operation from May, 2017. Mr. Monoranjan Mandal (aged 54 years), having more than a decade of experience in potato trading business along with Mr. Biswajit Bhakta (aged 57 years) and Mr. Srimanta Banerjee (aged 53 years) having around two decades of experience in potato trading business looks after the overall management of the company along with adequate support from a team of experienced personnel.
