## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated February 13, 2024, placed the rating(s) of Aastrid Life Sciences Private Limited (ALSPL) under the 'issuer non-cooperating' category as ALSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ALSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 29, 2024, January 08, 2025, January 18, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of ALSPL have been revised on account of non-availability of requisite information.
