### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 29, 2024, placed the rating(s) of S. P. Malik and Company Private Limited (SPMCPL) under the 'issuer non-cooperating' category as SPMCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPMCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 14, 2024, December 24, 2024 and January 03, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The Ratings assigned to the bank facilities of SPMCPL have been revised on account of non-availability of requisite information.

Since its inception, the company has been engaged in execution of civil construction works. SPMCPL undertakes civil constructions in the segments like construction & development of road, road over bridge.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SPMCPL into Issuer Not Cooperating category vide press release dated March 08, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
