Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 20, 2024, placed the rating(s) of Baba Bhubaneswar Cold Storage Private Limited (BBCSPL) under the 'issuer non-cooperating' category as BBCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BBCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 05, 2025, January 15, 2025, January 25, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Baba Bhubaneswar Cold Storage Private Limited (BBCSPL), incorporated in the year 2014, is a Kolkata (West Bengal) based company, promoted by Mr. Radha Raman Mondal, Mr. Swapan Kumar Ghosh, Mr. Basudeb Majhi and Mr. Manas Kumar Dhara. BBCSPL is engaged in the business of providing cold storage services to potato growing farmers and potato traders, having an installed storage capacity of 19,500 MT in Burdwan district of West Bengal, which is divided into two chambers. Mr. Radha Raman Mondal having more than two decades of experience in the cold storage industry looks after the overall management of the company along with the other directors Mr. Swapan Kumar Ghosh, Mr. Basudeb Majhi and Mr. Manas Kumar Dhara and supported by the team of experienced professionals.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of BBCSPL into ISSUER NOT COOPERATING category vide press release dated January 08, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
