Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 28, 2024, placed the rating(s) of Him Cylinders Limited (HCL) under the 'issuer non-cooperating' category as HCL had failed to provide information for monitoring of the rating and as agreed to in its Rating Agreement. HCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2025, January 23, 2025 and February 02, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Subsequently, it was converted into a public limited company in July 1999. The manufacturing facility of the company is located in Una district of Himachal Pradesh. The company manufactures the products according to the client's specifications and sells its entire output to the public sector oil marketing companies (OMC).
