Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 22, 2024, placed the rating(s) of Twincity Sunlife Private Limited (TSPL) under the 'issuer non-cooperating' category as TSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 07, 2025, January 17, 2025 and January 27, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Established in 2004 as a proprietorship entity by Mr. Bhuvnesh Chandra, Twincity Sunlife was later converted into a private limited company and renamed as Twincity Sunlife Private Limited (TSPL) in 2008. The company is engaged in trading of various solar equipment (modules, invertors, solar mounting structures and others), which find end-user application in solar power generation through the SPV (solar photovoltaic) power plants for households, corporate and the government.
