Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated February 12, 2024, placed the rating(s) of Shrikishan And Company Private Limited (SCPL) under the 'issuer non-cooperating' category as SCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 28, 2024, January 07, 2025, January 17, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SCPL have been revised on account of non-availability of requisite information.

Shrikishan and Company Private Limited (SCPL) was incorporated in March 2005 by Mr. Sharad Goyal and Ms. Sarita Agrawal. Since its inception, the company has been engaged in civil construction works like construction of buildings, roads etc. The company participates in tenders and executes orders for the various departments of Chhattisgarh and Odisha. SCPL is classified as 'Class A' contractor by the Government of Chhattisgarh which enables it to participate in higher value contracts.

Status of non-cooperation with previous CRA:

CRISIL has continued the rating assigned to the bank facilities of SCPL into ISSUER NOT COOPERATING category vide press release dated May 29, 2024 on account of its inability to carry out a review in the absence of requisite information.
