### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 06, 2024, placed the rating(s) of Nice International Limited (NIL) under the 'issuer non-cooperating' category as NIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 22, 2024, January 01, 2025 and January 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

New Delhi based Nice International Limited (NIL) is a closely held public limited company promoted by Mr. Aditya Mathur and his family members. The company currently is the authorized dealer of Kirloskar Oil Engines Limited and Action Construction Equipment Limited. NIL is engaged in the trading and assembling of generators sets, construction equipment, earthmoving and material handling equipments and related spare parts. Further, the company also procures the engines and other components from other OEMs like Escorts, TATA etc. and dealers for the purpose of trading. Besides the trading, the company also undertakes the operations and maintenance for power plants, HVAC (Heating, Ventilation and Air Conditioning) plants and diesel generator sets for own sold products as well as for others and solar roof top tower installation.
