Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 29, 2024, placed the rating(s) of Amrapali Smart City Developers Private Limited (ASCDPL) under the 'issuer non-cooperating' category as ASCDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASCDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 14, 2025, January 24, 2025 and February 03, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in 2010, Amrapali Smart City Developers Pvt Limited (ASCDPL) is an SPV promoted by Amrapali group. ASCD is developing a single group housing project in Greater Noida with total saleable area of 116 lsf on total land area of 61 acres. ASCDPL has acquired the land for the said project on lease from Greater Noida Industrial Development Authority on deferred payment basis for Rs.260cr. The company has launched the project in August 2010. In 2019, the Promoters of the company were sent behind the bars in an alleged case of defrauding homebuyers.
