Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated February 06, 2024, placed the rating(s) of Shreegopal Govind Sponge Private Limited (SGSPL) under the 'issuer non-cooperating' category as SGSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 22, 2024, January 01, 2025, January 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SGSPL have been revised on account of non-availability of requisite information.

About the company

SGSPL belongs to the "Shree Gopal Group" based out of West Bengal. SGSPL was incorporated in 2000 and is engaged in the business of manufacturing of sponge iron. The installed capacity is 45000 MTPA. The company procures its key raw materials such as coal, iron ore mainly from various players located in West Bengal and Odisha. The company sells its produce mainly to its associate company, viz. SCPL. The day-to-day activities of the company are looked after by Mr. Ram Kumar Sarda and Mr. Vishal Kumar Sarda both are having long experience in managing a steel plant and team of experienced personnel who are having adequate experience in similar line of industry.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SGSPL into ISSUER NOT COOPERATING category vide press release dated October 22, 2024 on account of its inability to carry out a review in the absence of requisite information.
