Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 14, 2024, placed the rating(s) of SCM Clothes Private Limited (SCMCPL) under the 'issuer non-cooperating' category as SCMCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCMCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 28, 2025, February 07, 2025, February 17, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SCMCPL have been revised on account of non-availability of requisite information.

M/s SCM Clothes Pvt Ltd (SCMCPL), is a company engaged in the retail trading of textile garments managed by Mr. P.P.K Paramasivam and his family. The erstwhile Chennai Silks group, founded in 1962 by Mr. A Kulandaivel Mudaliar, went through the process of demerger in 2012 among the family members, wherein the existing businesses were distributed among the seven sons of Mr. Kulandaivel Mudaliar, as part of the succession planning and settlement among the brothers. The brothers have taken over existing businesses/showrooms through newly incorporated companies and subsequently started expansion under new entities.
