### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 16, 2024, placed the rating(s) of Zimidara Pesticides (ZP) under the 'issuer non-cooperating' category as ZP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ZP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 02, 2025, March 12, 2025 and March 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the Firm

Zimidara Pesticides was established in 1990 by Mr. Om Prakash, the entity is engaged in wholesale trading of agrochemicals viz. pesticides, seeds and fertilizers of various types of herbicides, fungicides and insecticides etc. whereas the customers of the entity belong to various agrochemicals players. ZP is an authorized dealer and distributor of around 42 pesticides companies across Punjab. It operates its registered office in Abohar, Punjab.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of ZP into Issuer Not Cooperating category vide press release dated April 25, 2024 on account of its inability to carry out a review in the absence of requisite information.
