## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated April 25, 2024, placed the rating(s) of Techno Drugs And Intermediates Private Limited (TDIPL) under the 'issuer non-cooperating' category as TDIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TDIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 11, 2025, March 21, 2025 and March 31, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Established in March 1992, Techno Drugs & Intermediates Private Limited (TDIPL) as a private limited company and is engaged in manufacturing of intermediates and bulk drugs. The promoters of the company are Dr. Vipin Chandra Gandhi and Mr. Sameer Gandhi. TDIPL's manufacturing unit is situated in GIDC Panoli, Ankleshwar, Gujarat.

**Status of non-cooperation with previous CRA:** Acuite (SMERA) has continued the rating assigned to the bank facilities of TDIPL into Issuer Not Cooperating category vide press release dated September 27, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
