Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 06, 2024, placed the rating(s) of Dinkarrao B Mane Agro Industries Private Limited (DBMAIPL) under the 'issuer non-cooperating' category as DBMAIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DBMAIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 20, 2025, January 30, 2025, February 09, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of DBMAIPL have been revised on account of non-availability of requisite information.
