## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 19, 2024, placed the rating(s) of Shree Shivam Industries (SSI) under the 'issuer non-cooperating' category as SSI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 05, 2025, March 15, 2025, March 25, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Shree Shivam Industries (SSI) was established in March 2016 as a partnership firm by Mr. Gulshan Agrawal and Mrs. Priyanka Agrawal. The firm is engaged in rice milling, processing and trading of rice and its by products business and started its commercial operations since January 2017 at its plant, located at Dhamtari district of Chhattisgarh with aggregate installed capacity of 2,400 metric ton per month. Moreover, the firm has availed moratorium from its lender under the terms of recent RBI circular
