Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 14, 2024, placed the rating(s) of Motil Devi Organic Food Industries Private Limited (MDOFIPL) under the 'issuer non-cooperating' category as MDOFIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MDOFIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 28, 2025, February 07, 2025, February 17, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company started its commercial operation since April 2014 with an installed capacity of 15,00,000 litres per annum. The company market its products under the brand name of "Mental" in and around Raipur. Mr Deepak Wadhvani, Director, looks after the day to day operations of the company with adequate support from other director and a team of experienced personnel.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of MDOFIPL into ISSUER NOT COOPERATING category vide press release dated October 18, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
