Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 10, 2024, placed the rating(s) of SKD Jewellery Private Limited (Formerly Nikita Jewellery Private Limited) (SJPLNJPL) under the 'issuer non-cooperating' category as SJPLNJPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SJPLNJPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 24, 2025, March 06, 2025 and March 16, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SKD Jewellery Private Limited (SKDJPL) was originally incorporated in the year 2002 under the name of Nikita Jewellery Private Limited by Mr. Ashok Kumar Daga, Mr. Abhinav Kumar Daga and Mrs. Sushila Kumari Daga. Later on, in the year 2017, the name of the company was changed to current name. SKDJPL is engaged in manufacturing and export of gold and silver, diamond studded jewellery. The company mainly manufactures rings, earrings, pendants and bracelets.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of SKDJPL under Issuer Not Cooperating category vide press release dated June 04, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
