Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 23, 2024, placed the rating(s) of Saisons Trade & Industry Private Limited (STIPL) under the 'issuer non-cooperating' category as STIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 09, 2025, March 19, 2025 and March 29, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

STIPL incorporated in 1999, by Mr. Siddharth Shah, is engaged in manufacturing of various electrical and engineering products like electrical panel, fire panel & accessories, wire harness, accessories for telecom tower and fabrication of various products.
