# **Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated April 10, 2024, placed the rating(s) of Astra Lighting Limited (ALL) under the 'issuer non-cooperating' category as ALL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ALL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 24, 2025, March 06, 2025, March 16, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Astra Lighting Limited (ALL) was incorporated in 1997 with promoters and directors: Mr Paramjit Singh Chahal, Mr Parameet Singh Chahal and Mrs Gurbir Kaur. The company is engaged in the manufacturing of High Intensity Discharge Lamps (HID) used in infrastructure projects, floodlighting of monuments, stadiums, lighting of streets, highways, and parking areas (outdoor) at its manufacturing unit located at Solan, Himachal Pradesh.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of ALL into Issuer Not Cooperating category vide press release dated April 01, 2024 on account of its inability to carry out a review in the absence of requisite information.
